Description:

Renaissance Palace from the 16th century, it was one of the several residences enjoyed by one of the well-known Marquises of Catalan and great lineage of Spain. It is located near to Tárrega in the old town of a peasant village with services in the Urgell region, next to the church and the main square. The town has almost all the services without having to travel, very good communication by car and public transport and is very close to Lake Ivars d'Urgell, a natural area of great scenic beauty where you can enjoy nature and the birds.

The property is without a doubt one of the most important houses in the province of Lleida. The owners have carried out conservation work and the construction has been meticulously preserved and this has allowed it to preserve all the original elements that make it a special and unique property, arches, barrel vaults, wooden beams, terracotta floors, handicrafts, ornamentation on walls, cellars, stairs, porches, terraces, worked wooden doors of Arabic origin... endless details.... The house requires updating, but at a structural level it is in impeccable condition.

The Gardens: The property has 2 patios/gardens, one of them is located at the main entrance and was originally intended as a garden and another of the patios is walled, has access for vehicles and is surrounded in its upper part by a terrace and at the end of this a summer studio-pavilion, from which the Marquis could see and enjoy the views of his agricultural properties.

The Palace is made up of:

Ground floor: Grand entrance with stone staircase, several stables, stables for oxen, stables for mules, cellar, pantries, winepresses, granaries, area for shoeing animals. It preserves a whole series of elements that transport you and remind you of the splendid and agricultural past of the property.

1st Floor: Large hall that separates the day and night noble area with the service area. Large living room with fireplace, several rooms and lounges with fireplaces that were used for music, tea, receiving visitors, office, games of chance, several rooms, almost all of them with bedrooms, fireplaces and bathrooms, many of them with an exit. direct to the terrace, large pantry with original storage cabinet for household items, large kitchen with fireplace and oven, several bathrooms and nannies' room...

2nd and 3rd floor: The original floors are preserved, there is a central living room and several rooms and spaces, originally some were bedrooms and others were used as storage and drying for agricultural products as well as a drying room for slaughter products. The structure has some concrete slabs made to give consistency and the roof is in impeccable condition, ideal for those who need more space.
